ACLS invites applications for the fifth competition of the Public Fellows program. This year, the program will place up to 22 recent PhDs from the humanities and humanistic social sciences in two-year positions at partnering organizations in government and the nonprofit sector. Fellows will participate in the substantive work of these organizations and receive professional mentoring. This initiative, made possible by a grant from The Andrew W. Mellon Foundation, aims to expand the role of doctoral education in the United States by demonstrating that the capacities developed in the advanced study of the humanities have wide application, both within and beyond the academy. The ACLS Public Fellows program allows PhDs to gain valuable, career-building experience in fields such as public policy, international aid, conservation, arts and culture, and digital media. ELIGIBILITY: ACLS seeks applications from recent PhDs who aspire to careers in administration, management, and public service by choice rather than circumstance. Competitive applicants will have been successful in both academic and extra-academic experiences. Applicants must: (a) possess U.S. citizenship or permanent resident status; (b) have a PhD in the humanities or humanistic social sciences conferred between June 1, 2012 and May 31, 2015; (c) have defended and deposited their dissertations no later than the application deadline of March 17, 2015; and (d) not have applied to any other ACLS fellowship programs in the 2014-2015 competition year. FUNDING: Fellows receive a stipend of \$65,000 per year, as well as individual health insurance. The tenure is two years with a start date of mid-July or early September 2015, depending on the position.

The Jameson Award was established in 1974 to be awarded every five years for outstanding achievement



Books with an imprint of 2013 or 2014 are eligible for the 2015 award. **FUNDING:** There is no monetary prize, but the winner receives a certificate in recognition of the award.

The Henry Dreyfus Teacher-Scholar Awards Program supports the research and teaching careers of talented young faculty in the chemical sciences at undergraduate institutions. Based on institutional nominations, the program provides discretionary funding to faculty at an early stage in their careers. The award is based on accomplishment in scholarly research with undergraduates, as well as a compelling commitment to teaching. **ELIGIBILITY:** The Henry Dreyfus Teacher-Scholar Awards Program is open to academic institutions in the States, Districts, and Territories of the United States of America that grant a bachelor's or master's degree in the chemical sciences, including biochemistry, materials chemistry, and chemical engineering. Awardees are typically in departments that do not grant a doctoral degree. Nominees must hold a full-time tenure-track academic appointment, be after the fourth and not after the twelfth years of their independent academic careers, and be engaged in research and teaching primarily with undergraduates. Institutions may submit only one Henry Dreyfus nomination annually. Renominations are accepted. **FUNDING:** The Henry Dreyfus Teacher-Scholar Award provides a \$60,000 unrestricted research grant. Of the total amount, \$5,000 is to be allocated for departmental expenses associated with research and education. Charges associated with indirect costs or institutional overhead are not allowed. Defrayal of academic-year salary is not permitted. Funds are normally expended over a period of five years.

The aim of the International cancer technology transfer fellowships (ICRETT) is to facilitate rapid international transfer of cancer research and clinical technology, exchange knowledge and enhance skills in basic, clinical, behavioural and epidemiological areas of cancer research cancer control and prevention and to acquire appropriate clinical management, diagnostic and therapeutic expertise for effective application and use in the home organization upon return. Since its inception in 1976, the ICRETT fellowships have contributed to the development of the professional capacity of over 2500 ICRETT Fellows from over 110 countries by facilitating appropriate person-to-person training in specific areas that are relevant to the cancer research, clinical management and other cancer control activities being conducted in the Fellows' home countries. **ELIGIBILITY:** Appropriately qualified investigators, pathologists, epidemiologists, laboratory technicians, tobacco control activists and cancer registrars in the early stages of their careers; and

All proposed projects must have both a geographical dimension and relevance to other scientific fields and be of broad scientific interest. Applications are generally limited to the following disciplines: anthropology, archaeology, astronomy, biology, botany, geography, geology, oceanography, paleontology, and zoology. In addition the committee is emphasizing multidisciplinary projects that address environmental issues (e.g., loss of biodiversity and habitat, effects of human-population pressures). ELIGIBILITY: Applicants are expected to have advanced degrees (Ph.D. or equivalent) and be associated with an educational organization or institution. Independent researchers or those pursuing a Ph.D.-level degree may apply, but awards to non-Ph.D. applicants are rare. As a general rule, all applicants are expected to have published a minimum of three articles in peer-reviewed scientific journals. **FUNDING:** While grant amounts vary greatly, most range from U.S. \$15,000 to \$20,000. There is no set quantity of grants awarded, but budget constraints keep the number to approximately 250 per year. As National Geographic Society funds are intended to function as complementary support, the committee strongly encourages applicants to seek additional, concurrent funding from other funding agencies. Committee grants tend to act as seed money and are given for one year's research.

The Directorate for Engineering (ENG) and the Directorate for Computer and Information Science and Engineering (CISE), have joined to support the Research Experiences for Teachers (RET) in Engineering and Computer Science program. This program supports active long-term collaborative partnerships between K-12 Science, Technology, Engineering, Computer and Information Science, and Mathematics (STEM) teachers and community college and university faculty and students to bring knowledge of engineering or computer and information science and engineering as well as technological innovation to pre-college/community college classrooms. The goal of these partnerships is to enable K-12 STEM teachers and community college faculty to translate their research experiences and new knowledge gained in university settings into their classroom activities. The university team will include faculty, graduate and undergraduate students as well as industrial advisors. The maximum total request for a Site is \$600,000 for a duration of up to three years. Supplements are limited to a maximum of \$10,000 per teacher for a duration of one year.
