Eliaibility

- Funds for research and scholarly and creative activities shall be available to all full-time members of the instructional staff, and the untenured members of the faculty in particular, who are on the regular University payroll processed through the Office of the Comptroller of the City or State of New York.
- Individuals may apply to only one of the three types of awards (Traditional A, Traditional B, or Enhanced) in any given year.
- Faculty are not eligible to apply for or receive a Traditional A or B Award for any year in which they have received or will receive external grant funding or awards of \$100,000 or more in direct costs for their research. A faculty member who is awarded such external funding after submitting an application for a Traditional A or B Award must withdraw his/her Traditional A or B application.
- Tenured faculty may not receive more than two awards during the three-year period of the Pilot

Program, only one of which may be an Enhanced Award.

- Faculty members on sabbatical or scholar incentive leave may apply for and receive awards. Instructional staff members on other leaves may apply for an award, but must have returned to work and be back on full-time University payroll to access a PSC-CUNY
- Members of the University Committee on Research Awards (UCRA), comprised of the Review Panel Chairs, are not eligible for awards. Other Panel members are eligible to apply for awards; however, they must recuse themselves from the consideration of their own applications.
- An individual may not submit more than one application in any one PSC-CUNY Award Competition, as a Principal-Investigator (PI) or Co-PI.

These awards are intended to support coral reef conservation projects in shallow water coral reef ecosystems, including reefs at mesophotic depths, in American Samoa, the Commonwealth of the Northern Mariana Islands, Florida, Guam, Hawaii, Puerto Rico, the U.S. Virgin Islands, and coral-dominated banks in U.S. portions of the Gulf of Mexico. Projects may be proposed in the Northwestern Hawaiian Islands and the U.S. Pacific Remote Island Areas (PRIA), but these locations are not considered geographic priorities under this announcement. Proposals submitted to this competition must address at least one of the following four categories: 1) Fishing Impacts; 2) Land-Based Sources of Pollution; 3) Climate Change; and 4) Local and Emerging Management Issues. ELIGIBILITY: Institutions of higher education, non-profit

organizations, commercial organizations, and local and Indian tribal government agencies. **FUNDING:** Proposals selected for funding through this solicitation will be implemented through a grant and will require a 1:1 match of non-Federal funds. Funding for this program is expected to range between approximately \$500,000 to approximately \$1,000,000. Funding will be divided among the U.S. Pacific and Atlantic regions to maintain the geographic balance of the Coral Grant Program portfolio overall, as required by the Coral Reef Conservation Act of 2000. NOAA expects that each applicant will request Federal funding at a funding level between \$30,000 and \$80,000 under this solicitation and that the average award size will be approximately \$50,000.

The Omohundro Institute of Early American History and Culture offers a two-year postdoctoral fellowship in any area of early American studies, to begin July 1, 2013. The Institute's scope encompasses the history and cultures of North America's indigenous and immigrant peoples during the colonial, Revolutionary, and early national periods of the United States and the related histories of Canada, the Caribbean, Latin America, the British Isles, Europe, and Africa, from the sixteenth century to approximately 1820. Fellows devote most of their time to research and writing, work closely with the editorial staff, and participate in colloquia and other scholarly activities of the Institute. ELIGIBILITY: A principal criterion for selection is that the candidate's dissertation or other manuscript have significant potential as a distinguished, book-length contribution to scholarship. A substantial portion of the work must be submitted with the application. Applicants may not have previously published or have under contract a scholarly monograph, and they must have met all requirements for the doctorate before commencing the fellowship. Those who have earned the Ph.D. and begun careers are also encouraged to apply. The Institute holds first claim on publishing the appointed fellow's completed manuscript. FUNDING: In addition to a beginning stipend of \$50,400, the fellowship provides office, research, and computer facilities as well as some travel funds for conferences and research. A Fellow holds a concurrent appointment as visiting assistant professor in the appropriate department at the College of William and Mary and teaches a total of six semester hours during the two-year term. The calendar year 2014 is reserved solely for research and writing. Institute fellows also have the option of spending a summer at the Huntington Library on a full grant within five years of their residency in Williamsburg.

The program also develops the careers of its recipients through professional development activities involving National Academy of Education members. ELIGIBILITY: Applicants must have received their PhD, EdD, or equivalent research degree between January 1, 2007, and December 31, 2012. Applicant should have a demonstrated record of research experience in education. Proposed project must be an education research project. Non-US citizens are welcome to apply. The program is open to all eligible applicants regardless of race, national origin, religion, gender, age, disability, or sexual orientation. FUNDING: Fellows will receive \$55,000 for one academic year of research, or \$27,500 for each of two contiguous years, working half-time. Fellowships must begin during the 2013-2014 academic year. Fellows take the equivalent of one year's teaching leave during the fellowship term. Fellows will be included in professional development retreats with other fellows and NAEd members. Up to twenty postdoctoral fellowships will be awarded in 2013.
